Chief Executive Officer Report

2022-2023 was a year of being at the frontline within the community. The Pearce Community Garden was completed with many families from the suburb managing their own vegetable plots, using the community library, and enjoying the inviting open garden spaces. The Pearce Community Centre may be slightly hidden away but it is evident that the area is an important space for the local and wider community. To commemorate the gardens completion and to celebrate the Jubilee of the Queen's coronation a Jubilee walk was launched on the 3rd of December. This was yet another great example of SHOUT bringing the community together.

The Pearce Crafter Markets are held quarterly at the Pearce Community Centre and sponsored by SHOUT by providing free spaces for stall holders with hundreds of people attending over the two-day event. SHOUT provided affordable tenancy for five community organisations within the Pearce Community Centre. Meeting our obligations as a capacity building and resource for the community sector, many organisations are unable to afford commercial market rate rent and along with the tenancy, SHOUT provides administrative and mentoring support which assists in their ongoing sustainability.

We continued to publish our bi-monthly newsletters which are an important mechanism for our members to share information on their services and connect the community with organisations that provide essential services to those in need.

During the year SHOUT provided strategic planning facilitation for several community organisations which helps create the guiding document of goals and outcomes, a cornerstone of good strategic governance. We also provided executive coaching and mentoring for several Chief Executive Officers within our membership base. Often, CEOs are appointed with little or no executive experience and one of our key goals is to ensure that the sector retains good, knowledgeable leaders that contribute to a sustainable and vibrant community sector. The importance of this work cannot be understated.

At the end of the year Carol Mead, the CEO for the past several years, announced her retirement and a new CEO was recruited. Carol carried the organisation through the challenging period of COVID and ensured that the new CEO had a sound organisation to manage. SHOUT will be eternally grateful for Carols service. Torrien Lau, a very experienced sector CEO accepted the role and commenced in the last week of 2022 – 2023 and we look forward to his leadership in the coming year.

Chair Report Report

2022/2023 has finally seen some stabilization in our community and the world more generally. I don't think the world will ever be the same following the Pandemic, but it is nice to know we can plan and deliver programs again without the constant worry of shutdowns and illness. Moving forward, however, hasn't always been easy. We no longer live in quite the same world we lived in 4 years ago. We've grown, we've changed how we look at the world, we do things differently in a way that without the Pandemic we may not have ever got to, or at least not in the timeframes that we have as a result of it. Some of these changes are positive, but some have seen a reduction in how we mix within the community, and we are now seeing higher levels of social isolation, especially in those who most need social connections, than we did in the past.



The community sector has been one of the areas in the local landscape that has seen a full return to work in the workplace and this is largely because our work revolves around people. This does create a new challenge though in a job market like the ACT where there are opportunities to work from home in other sectors where work is more desk related and as such the community sector is finding it harder to attract workers who are prepared to leave home for every shift when so many other options exist. We are also finding in the sector that the increasing level of regulation, which whilst good at ensuring safe, evidenced-based practices, is leading to a drain within the system. Whilst we see an exodus of staff leaving for opportunities that include a higher level of work from home and family friendly practices, we are also seeing an exodus of staff who can no longer deal with the increasingly bureaucratic side of their workload. The need to physically support the community hasn't decreased, in fact it has largely increased, however organisations are not supported through funding models to meet and constantly improve on the standards of service delivery, and overworked staff are voting with their feet and are leaving the industry, increasing the risk as years of experience and passion leave for a simpler life. We collectively call upon Governments to consider appropriately funding this sector so that it can both meet the administrative overheads that is rightly expected but can also deliver quality services to our community members.

After five years (and she only came initially for 6 months) we have said goodbye to Carol Mead as our CEO. Carol skillfully guided SHOUT through some of the biggest changes and then the challenges of the Pandemic years with strength and grace. She came out of retirement to undertake this challenge, and we are so grateful that she was able to guide our members through such emotionally charged times. As she heads off into her version of retirement, we have been thrilled to welcome Torien Lau to the helm to take SHOUT into the next chapter of its being. Torien comes with a wealth of experience in running community organisations, large and small, and has a well-established profile in our sector which can only benefit SHOUT and all our members. I regretfully will be standing down from the Board at the AGM. Having taken SHOUT through the 'great fight' of the late teens to ensure its survival, I need to now concentrate on a family that needs me. It has been a pleasure working with each and every one of you and I know that I am leaving SHOUT in confident and trusted hands with Torien and the new Board.

SHOUT offers a number of programs and services to members which are seen as key roles of the organisation to benefit the members. These services assist organisations to grow and build capacity, remain viable and develop strong and purposeful services and plans.

Strategic Planning

This year SHOUT has had the pleasure working with a number of organisations to faciliate and formulate their stategic plans. These plans assist organisations to identify their strategic directions and the goals of how to get there. While strategic planning is not a difficult concept, before SHOUT offered these services, there had been a lot of expense often spent on corporate strategic plans which had little value - as organisations often sought the consultation of large commercial organisations who, it must be said, had little experience or knowledge of the sector, so the result was usually an unworkable document which did not meet the requirements of the brief.

Board Governance

While in the past SHOUT had availed the expertise of a Sydney based training organisation - we have continued to provide a low cost short 3 hour course for our members in Board Governance which was again successful. SHOUT now offers the training to Boards and Board Members across the sector, and tailors courses to meet individual needs of organisations.

Executive Support

Mentoring CEOs is a very time effective strategy to assist them to understand and learn skills and techniques to better lead into the future, especially through times of change. In the past this was done through counselling services, but we found that CEOs appreciate being mentored by an experienced CEO from the sector. We have identified that this cerainly looks like an area of growth for SHOUT in the future, who could undertake training for suitably experienced CEO's to become mentors in the sector. Currently the SHOUT CEO is mentoring five CEOs from member organisations, and informally coaching and supporting many others.

Membership

Our membership continues to grow as it is valued by organisations across the community sector. SHOUT offers two membership levels - both Affiliate and Corporate - and they are offered a range of services to build a connected, vibrant and strong community sector in Canberra. We welcome new memberships and look forward to assisting new members wherever we can.

Web of Support

Funded through the NDIS the Web of Support continues to be a valuable resource for Canberra in services offered through the disability, health and aged sectors. With over 180 local listings which are up to date and relevant, it is sourced regularly at all times of the day and night. Several organisations use the Web of Support as a referral database.

Pearce Inclusive Community Garden

Like in other years we have continued to strengthen the Pearce Community Garden with a series of funding to develop the space and make it meet the needs of both our program attendees and the wider community. The garden has grown through various stages into a productive vegetable garden which is now leased to community groups and individuals and a beautiful completely accessible garden, complete with shelter, chairs and a community library.

In 2023 the Jubilee Walk was added to the garden to add more colour and create natural habitat for the birds and wildlife. We have also added another set of seating and are looking at more funding opportunities to add some shade sails when they become available.





In 2020 we received funding through the Healthy Canberra Grants which employed our Horticulturist and Gardener, Courtney Tindale - who has brought her expertise into our garden 5 hours a week to further develop and nuture the space. The funding also brings together an excercise program with Arthritis ACT and is already proving to be very successful in helping people with muscular skeletal issues active, safe and involved.

SHOUT has continued offering a community garden program for volunteers, and while COVID has hampered our take up of this program we have a small team of committed volunteers, and we are able to support them well with the Health Canberra Grant.

We have further developed the the Under 5's Playground with more plantings and play equipment which is being used by our littlest visitors. The Liberty Swing is also being used by the attendees of the disability programs held in the Centre. This is a particular focus for those families who are visiting Kidsafe, but throughout the day this little playground is used extensively on the weekend as well as through the week.

We are grateful for the opportunities offered by ACT Government and especially through funding opportunities which have been instramental in the initial development and building the garden space. We wanted to create a hub of activity and are delighted to have a number of community groups who are leasing garden plot spaces, and as we hand over the reigns to the Pearce Community Centre, we know that this active and vital space will continue to thrive.
